◆ **1930s** Glenn Hegeman '33 celebrated his 100th birthday May 17 with friends and relatives. Other centenarian alumni include Howard C. Lindemann '32, John P. Rudolph '35, Charles Ray Jr. '37, and Jerome A. Ehrlich '43. Russell Jacob Fornwalt '34 will reach his century milestone this month.

Barry Friedman '38 has published his 12th book, *Fracture*, a suspense-thriller. The plot involves a young orthopedic surgeon who is developing a method for healing fractures in considerably less time than treatment by conventional methods. Because the method will revolutionize the treatment, attempts are made to sabotage his work by those who see it as a threat to their business. A biology graduate, Friedman received his medical degree at New York University School of Medicine, and after service as a Navy medical officer during World War II, he practiced orthopedic surgery in Cleveland until his retirement in 1980. James T. Holcombe '37, 94, of Mountainside, N.J., passed away June 11. A mathematics graduate, he received a master's from Columbia University. For more than 50 years, he represented educators in New Jersey through extensive involvement in the New Jersey Education Association. He taught math and science at Union High School for 17 years and was principal of Livingston School, Union, N.J., for 25 years. He served on the board of trustees of New Jersey Teachers' Pension and Annuity Fund for 24 years and was chair for 15. He served two terms on the executive board of National Council on Teacher Retirement and was twice a delegate to the White House Conference on Aging. Holcombe's advocacy of teacher benefits and rights resulted in the adoption of social security benefits for New Jersey teachers. In 2001, NJEA honored him with the Ruthann Sheer Award for Distinguished Service to Education for his extensive service to the educational community, a record that includes serving as president of New Jersey Retired Educators Association (1994–98); member of the NJEA Convention Committee; president of Union County Education Association and Union County Retired Educators Association; and treasurer of UCREA for 25 years. A charter member of Community Presbyterian Church, he was a member of the choir and served as treasurer for 25 years. He also sang with Saengerchor Newark and The Graduates, the Lafayette alumni chorus. Survivors include his wife of 66 years, Evelyne; daughter Joanne and son-in-law Joseph Campana; and son Randall

and daughter-in-law Connie. His brother, John Gibson Holcombe '23, predeceased him. Donations may be made to the Jim Holcombe Memorial Fund, Community Presbyterian Church, Saengerchor Newark, or The Graduates.

No one in the barracks would believe him when he insisted the base was under attack. In moments, aircraft on Wheeler Field went up in flames, joined by a massive cloud of smoke rising from the remains of a large portion of the American fleet. In 1978, he retired and made his home in Longboat Key, Fla. Wife Madolyn predeceased him.

More about the late **John Miller Light**. John and I (**Anthony Noto**) were Easton High School, as well as Lafayette, classmates. John would have had a successful career no matter what he chose to do. That he chose the pulpit speaks for itself. John had a keen wit. No doubt his sermons featured a bit of humor. He was humorous even about his name, as in "Miller Light" beer. I doubt John ever sipped a drop of it, but he enjoyed kidding about it. I cherished his friendship. John's wife, who predeceased him, was the sister of the Rev. **Wallace Baum**.

In mid-July, I had a phone conversation with Dr. **David Silverstone**. Though his mobility is limited, he copes alone in his Stratford, Conn., home. Each morning, someone comes to prepare his breakfast. I will keep in touch with him.

I also phoned **Mayo Lanning**. He turned 96 in May. He is generally confined to his apartment, his mobility limited. His oldest daughter keeps tabs on him, driving him to appointments. He has a variety of problems, including two leaky heart valves. When I asked him about his eyes, he said he is able to read printed material. He has a computer and is skilled at using it. Mayo also sent a two-page letter reviewing his four years at Lafayette.
