1930s Emily Christman

Szymanski '94 reports the death of her grandfather, Dr. **Franklin D. Zimmerman '39**. He passed away Jan. 3, only two days after his 96th birthday. Franklin came from rural Schaefferstown, Pa., and was called "Dutch" by some of his classmates due to his strong Pennsylvania Dutch accent. He majored in biology and was a member of the Delta Tau Delta fraternity. He married Kathryn Overly in April of his senior year and graduated from Jefferson Medical College in Philadelphia in 1943. Only nine months into his residency at Lancaster General Hospital (Pa.), he was drafted into the U.S. Army to serve in the medical corps as support for the Chinese army on the Burma Road. In 1946, he returned to Schaefferstown to begin his family medical practice. He retired from medicine in 1989 at age 72. Although not an obstetrician, he delivered more than 1,000 babies, many in the homes of his Amish and Mennonite patients. He had five children, 11 grandchildren and 21 great-grandchildren. He enjoyed golf, fishing, mushroom

hunting, astronomy, and reading about the latest scientific discoveries. He traveled to all 50 states, many countries in Europe, and the former Soviet Union in the 1960s. He attended his 60th reunion in 2009 and was given the privilege of riding in a classic Corvette in the parade.

Dr. I. Charles Kaufman '39 died Oct. 22, 2011. A chemistry graduate, he earned his M.D. at Long Island College.

Joseph McDonough '39 died Oct. 8, in Greensboro, N.C. He was raised in Newark, N.J., and moved to Allenhurst, N.J., with wife Geraldine in 1946. A mechanical engineering graduate, he worked for Bendix Aviation Corp. on equipment for the Royal Air Force. During World War II, Joe was in charge of teams of predominately female workers, who joined Bendix in support of the war effort. Succeeding his father as owner of McDonough's Florist in Newark from the late 1950s to the mid-1970s, Joe ran the business before joining Briscoe Construction Co. in 1974, where he worked until retirement in 1992. Since December 2009, Joe resided in Greensboro with his wife, who survives him.

Vincent J. "Vince" Stanley '39 died Nov. 11. He was born Dec. 22, 1916. He lost his father in a mining accident when he was in his teens and started working in the mines of Scranton, Pa. He put himself through college and received a Phi Beta Kappa key in his junior year. He enlisted in the Army Air Corps during World War II and was stationed in England, where he met his wife of 64 years, Evelyn. Upon leaving the military, he worked briefly for Philco Corp. in upstate New York before forming his own business,

V.J. Stanley Co. of Rochester. Vince was an avid tennis player well into his 80s. In May 1999, he received the Monroe County (N.Y.) Rotarian of the Year Award. Other awards include honorary chairman of the Rochester Literacy Commission, 2007 RACF Philanthropy Award, Silver Nail Award from Habitat for Humanity, and 2009 Senior Citizen of the Year Award. Vince was president of the Rochester Red Wings baseball team for a number of years.

died Sept. 22. At Lafayette, Wallace was a pretheology student and was active in choir. He was elected to Phi Beta Kappa and graduated magna cum laude. A pastor in two United Church of Christ churches, he later joined Bethany Children's Home, serving as a department director until retirement. He is survived by his wife, Mary, and sister, Mary Light, wife of the late Rev. **John M. Light**.

John C. Tyndall died Oct. 21, 1998, shortly before his 80th birthday. While at Lafayette, he was a member of Sigma Chi and Interfraternity Council.

Robert F. Mills, 92, died Nov. 12. The late researcher **Phil Leslie** noted a sole reference to Mills as a freshman in the 1937 College Catalog. Mills served in the Army during World War II and later worked as a parts manager at Mack Trucks. His wife, Margaret, predeceased him. The last time I (**Tony Noto**) saw Mills was in 2007

A highlight of Brandon's third season as a starter in the defensive backfield was his selection to the Capital One All-District II Football Team. **Jason Marshalek '13** is a civil engineering major and is on-track to graduate in May. an economics graduate who received an MBA from Harvard Business School, and rose in prominence as an entrepreneur, industrialist, and philanthropist, passed away Nov. 2 in Los Angeles. Larry learned the cement business as assistant to the president of Riverside Cement Co. He subsequently became CEO of National Portland Cement Co., Bradenton, Fla., and later cofounded Pacific Coast Cement Co., Los Angeles. He served as chair and CEO of Bruning Paint Co., Baltimore, and later as chair of Ramer Equities, focused on acquisition and development of manufacturing companies. He also undertook corporate turnarounds for Bank of Pennsylvania. Active in volunteer and philanthropic activities, Larry served on the Lafayette Board of Trustees for 30 years, including nine as chair. He also served on the board of directors of ORBIS International, a flying hospital offering eye care and surgical procedures to developing nations. Larry supported arts and education in Los Angeles, serving as president and chair of the Center Theater Group and chair of the California Institute of the Arts. He was a longtime member of the American Jewish Committee, for which he served as treasurer. After the fall of the Berlin Wall, he founded the Lawrence and Lee Ramer Institute for German-Jewish Relations. He was decorated with the Commander's Cross of the Order of Merit of the Federal Republic of Germany. Larry was also a member of the Council on Foreign Relations. Lee, his wife of 55 years, survives him.

Ralph W. Viguers Sr. died in Paoli, Pa., Nov. 15. A graduate of Lower Merion (Pa.) High School, he was a member of its 1942 and 1943 state championship basketball teams. An economics graduate, he spent three years with Sun Oil Co. in its insurance department. Ralph spent more than 50 years raising public awareness about the detrimental effects of smoking and air pollution. His career in the health field began with Philadelphia Tuberculosis and Health Society, later renamed Pennsylvania Lung Association. In

later years, he worked with Delaware Lung Association and Bucks County (Pa.) Lung Association.

On Aug. 29, **Edward A. "Ed" Flood Jr.** of Gladwyne, Pa., passed away. An economics graduate, Ed had a successful career as a senior corporate lending executive with Philadelphia National Bank. He later graduated to larger boats and competed in events such as the Newport to Bermuda Race and the Corinthian racing events in the Chesapeake Bay and New England. 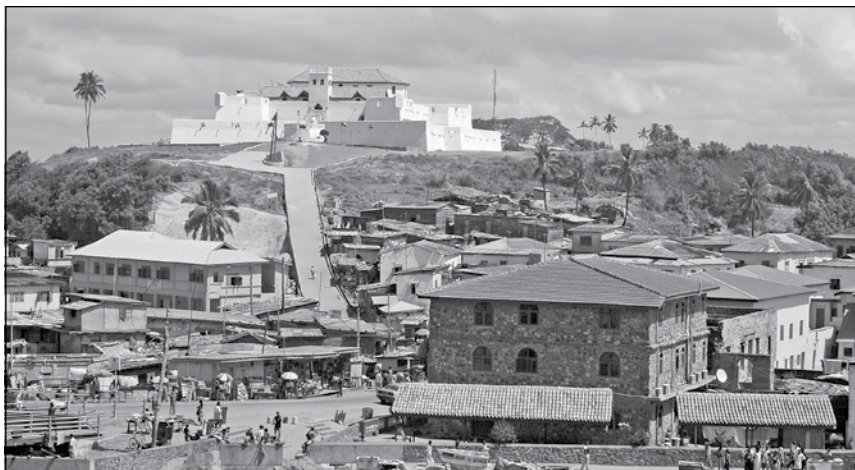
